ADDITIONAL INFORMATION/TRAINING

- 1 I, for myself and on behalf of my heirs, assigns personal representatives and next of kin, HEREBY RELEASE, IDEMNIFY, and HOLD HARMLESS JunglePlex, Plymouth Adventure Park LLC, KONIDA LLC, their officers, game officials/referees, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event ("releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
- 2 I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown of my child's participation in the JunglePlex, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for his/her participation; and
- 3 I willingly agree to comply with the stated and customary terms and conditions for my child's participation in JunglePlex programs. If, however, I observe any unusual significant hazard during my or my child's presence or participation, I will remove my child from participation and bring such hazard to the attention of the nearest instructor immediately, and,
- 4 The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist: and,
- 5 Arbitration. In further consideration of allowing my child to participate in the aforementioned activities, I hereby agree to submit to binding arbitration regarding any and all claims which I believe I or my child may have against the facility arising from my child's activities at the facility. The arbitrators shall apply the Federal Rules of Evidence to all proceedings.

Arbitration shall be commenced within one (1) year from the date of which any alleged claim first arose. Further, the arbitration shall be held in the town where the Arena is located, unless otherwise mutually agreed to by all parties. The submission to the American Arbitration Association shall be unlimited and the arbitration award may be enforced in any court of competent jurisdiction.
